Welcome and Introductions

• All members introduced themselves and their respective organizations and roles.

ECCS update

- HRSA MIECHV/ECCS Tri-Regional Forum: Kareena and Heather gave an overview of July's forum. Highlights include: collaboration with CT MIECHV team, creating displays featuring ECCS work and participating in networking with other states, ECCS breakout discussions with other states and with HRSA Project Officer, and exclusive meeting with Dr. Willis to discuss the future of ECCS. Systems development was emphasized.
- Paul Dworkin commented on the big picture regarding ECCS and its future. Potential emphasis from HRSA to continue in the area of developmental screening, especially in integrating existing systems to do developmental promotion, early detection, and referrals and linkages.
- Discussed importance of forging connections with MIECHV and HV COIiN and the HV Consortium, as the prominence of home visitation will be an explicit part of the process. It is important to integrate systems of facilitators (i.e. health consultant, home visitors, etc.) for developmental promotion on a continuum of services. There are a various initiatives to connect: Birth to Three, Home visitation, the Infant/Toddler agenda for the EC Cabinet, SIM grant/DSS, screening for adverse events. It was reiterated that the connection is always the challenge not to operate in parallel processes
- Paul Dworkin asked for feedback for Dr. Willis as he is reforming the new ECCS grant. He will communicate this group's feedback directly to Dr. Willis.

• An overview of the Project Matrix objectives and five Priority Areas was given, as well as the process for further design. Each of the five objectives has a designated planning document with a planning
